- RIZIV/INAMI-number.
- Data relating to the subscription.
- Data for calculating, recording and collecting subscription fees.
- An indication of the reason for determination of the subscription.

You guarantee that the data you provide is correct and complete. The provision of incorrect data or data belonging to third parties may result in a temporary or permanent ban on access (in whole or in part) to the products and services of our company.

Sharing with others

Only the user's surname, first name and shipping address may, if necessary, be disclosed to the authorised persons processing the data and their principals, as well as to the third parties. This is permitted for the dissemination of useful information; also for commercial purposes, unless you do not agree. Objections can be made at any time at the end of the registration procedure. This will put you on a Robinson list. This is a list of names and addresses of people who no longer wish to receive undelivered, addressed advertising material.

Usage of Cookies

We also collect non-personal data through an automated way, such as cookies.
